Brooks Links Membership Rules and Regulations

- No refunds are available for Brooks Links Memberships.
- Membership is valid for the 2023 season. Membership expires 12/31/2023.
- Membership is non-transferable.
- All members are required to check in with the golf shop before playing.
- No outside food or beverage will be allowed on the golf course property.
- A cancellation courtesy call of 24 hours is requested for all tee times.
- Members are responsible for any excessive damage they may cause to the facility, property or golf cart.
- Members may be asked to leave the premises, or have their membership suspended or revoked for any of the following: physical or verbal abuse of customers or staff, destruction of club property, providing member benefits for non-members, and any violations of Naperville Park District policies or rules.
- The courses may be closed from time to time, due to weather, maintenance issues or other events.

WARNING OF RISK

Warning of Risk: Recreational programs are intended to challenge and engage the physical, mental, and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury when participating in any recreational program. Understandably, not all hazards and dangers can be foreseen. Depending on the particular activity, participants must understand that certain risks, dangers, and injuries due to inclement weather, slipping, falling, poor skill level or conditioning, carelessness, horseplay, unsportsmanlike conduct, premises defect, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor, outdoor, and water related recreational programs exists. In this regard, it must be recognized that it is impossible for the Naperville Park District to guarantee absolute safety.

Waiver and Release and Assumption of Risk: Please read this information carefully and be aware that in registering for and participating in this program, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program (including transportation services, when provided). I recognize and acknowledge that there are certain risks of physical injury to participants in this program and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program against the Naperville Park District, including its officials, agents, volunteers, and employees (hereinafter collectively referred to as "Naperville Park District").

Release: I do hereby fully release and forever discharge the Naperville Park District from any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with this program.
